American Legion family eligibility requirements

The American Legion

Any person is eligible for membership who was a member of the U.S. Army, U.S. Navy, U.S. Air Force, U.S. Marine Corps or U.S. Coast Guard and assigned to active duty at some time during any of the following periods: April 6, 1917-Nov 22, 1918; Dec 7, 1941-Dec 31, 1946; Jun 25, 1950-Jan 31, 1955; Feb 28, 1961-May 7, 1975; Aug 24, 1982-July 31-1984; Dec 20, 1989-Jan 31, 1990; and Aug 2, 1990-present. Merchant Marines who served from Dec 7, 1941, to Dec 31, 1946, and have been deemed veterans are eligible for membership. Those who have left the service must have received an honorable discharge. Membership also is open to those who were citizens of the United States at the time of their entry into foreign armed forces that served with the United States during any of these periods. Service must have been terminated with an honorable discharge or honorable separation.

American Legion Auxiliary

All women who are eligible for membership in the Auxiliary fall into one of these categories:

- The mothers, wives, daughters, sisters, granddaughters, great-granddaughters and grandmothers of members of The American Legion.
- 2. The mothers, wives, daughters, sisters, granddaughters, great grand-daughters and grandmothers of those who served in the U.S. Armed Forces during any of the eligibility periods listed and who died in the line of duty during such service, or who, having received an honorable discharge, died after such service.
- 3. The mothers, wives, daughters, sisters, granddaughters, great-granddaughters and grandmothers of those who were citizens of the United States and who served during any of the eligibility periods in the armed forces of any of the governments who were allies of the United States and who died in the line of duty during such service, or who, having received an honorable discharge, died after such

service

 Women who are delib8ible for membership in the Amer can Legion in their own right. Eligibility includes steprelatives.

Sons of The American Legion

An eligible member must be a male descendant or stepso of a member of The American Legion. Others eligible to join include:

- Male descendants, stepsons included, of any veteran who died in service during World War I World War II, the Korean War, the Vietnam War, Lebanon, Grenada, Panama or the Persian Gulf War. See specific time period fo service during these conflicts.
- 2. Male descendants and stepsons of a veteran who died subsequent to his or her honorable discharge from service in World War I, World War II, the Korean War, the Vietnan War, Lebanon, Grenada, Panama or the Persian Gulf War The same eligibility periods apply.

Facility Manager

There has been a lot of activity in this area since the last newsletter. Let me bring you up to date on the major items. First, our contractor has completed termite damage repair on the floor supports under the dental lab next to the club house. That was "must do" work. Other less critical termite damage exists under the Hall. But for now, the termites have been exterminated.

As you may have heard, the Post has terminated the lease with Sweetwater Station and is now managing the hall, lounge and kitchen. In fact, there appears to be a strong demand in the community to rent the hall for a variety of events. We have already rented the hall for musical recitals. However, in order to bring the facility up to full vigor, it is necessary to complete some maintenance and repair long neglected by tenants over the years.

The Post business plan calls for leasing the kitchen to a caterer to provide a steady income for the Post. An in-house caterer will also enhance the desirability of the hall as an event site. We are planning to have the commercial range professionally restored to new condition and have the commercial dishwasher repaired. We must turn over a properly functioning kitchen to the future kitchen tenant.

Much discussion has been devoted to the main hall. Issues such as lighting, sound system, modifying the stage, floor covering, and the like, are front and center. It seems certain that the hall will not be primarily a venue for plays and musicals in the future. Therefore, the stage should be reduced in size or even removed. Increasing the floor space by shrinking the stage will increase the capacity of the room. We are exploring the options to determine the best configuration for the hall.

The business plan has the Post operating the lounge as a bar serving beverages for events in the hall. We are obtaining the necessary licenses and permits this very moment. The bar must be equipped with shelving, glasses, and all necessary fixtures to operate. Appropriate liquor inventory is also needed as is security for said inventory.

The purpose of all these changes, and others still on the drawing board, is to enable the Post prosper and grow. Additional revenue and free use of the facility will support our mission of service to veterans, our members and the community.

Several years ago your Executive Committee decided to increase our capital reserves to hedge against the potential loss of our long term tenant.

The loss of Sweetwater Station as our major tenant occurred in late December. After many meetings, your Post decided to reclaim control of the main hall and manage the property with short rentals. This is a major undertaking as we anticipate some months going forward with negative cash flow.

The foresight of establishing a reserve fund will permit us to weather this financial period as we build our rental business.

A major milestone was reached Friday February 13, when the Post signed an agreement with Marin Realty Group to list and manage our short term rentals. Not only will this relieve the Post from this management intensive activity, but we will benefit from the advertising and marketing expertise of the Marin Realty Group.

As our rentals increase there will a continual property improvement process to upgrade our property. Going forward we must minimize our expendi-

tures where we can while being ever mindful of our spending to enhance our appeal for future rentals.

Shinseki vows 21st-century service to veterans

Retired Army Gen. Eric K. Shinseki took the oath cess for returning Iraq and Afghanistan veterans. of office Jan. 21 as the nation's seventh secretary of Veterans Affairs, assuming the leadership of the Department of Veterans Affairs following Tuesday's confirmation by the Senate.

"The overriding challenge I am addressing from my first day in office is to make the Department of Veterans Affairs a 21st-century organization focused on the nation's veterans as its clients," Shinseki said. He plans to develop a 2010 budget within his first 90 days that realizes the vision of President Obama: to transform VA into an organization that is peoplecentric, results-driven and forward-looking.

Key issues on his agenda include smooth activation of an enhanced GI Bill education benefit that eligible veterans can begin using this fall, streamlining the disability claims system, leveraging information technology to accelerate and modernize services, opening VA's health-care system to veterans previously unable to enroll in it, and facilitating ac-

Shinseki, a former Army chief of staff, takes the reins of a 284,000-employee organization delivering health care and financial benefits to millions of veterans and survivors under a \$98 billion budget authorized this year, through networks of regional benefits offices and health-care facilities from coast to coast.

Born Nov. 28, 1942, on the island of Kauai, Hawaii, **Shinseki** graduated from the U.S. Military Academy at West Point in 1965. He served two combat tours in the Vietnam War and was wounded in action. His military decorations include three Bronze Stars and two Purple Hearts. He served with distinction in Europe, the Pacific and stateside, eventually becoming the Army's senior leader from June 1999 to June 2003.

Shinseki succeeds Dr. James B. Peake as secretary of Veterans Affairs.

The boys and the fathers were a handsome lot and the dads were enthusiastically participating in the classification of potential players so that they could be assigned to the league teams in groups of balanced


> abilities. Outcome of the season will be the spirit of the boys and the effectiveness of the coaching by the volunteer dads.
