

Dave joined the US Army at the age of 18 and served as part of the 1st Engineer Brigade. He was a member of the Normandy D-Day landing force at Omaha Beach in 1944 and the following year he saw service in Okinawa in the Pacific Theater of operations.

Dave was extremely proud

of his service to this Nation and was grateful for his opportunity, many years later, to visit the Normandy Beaches during the 50th anniversary celebration of D -Day and to visit Washington, D.C. in conjunction with the dedication of the World War II Memorial.

Following his military service, Dave joined the Corte Madera Police Dept. where he rose through the ranks to become Chief of Police. He served with the Corte Madera Police Dept. for 25 years.

Dave was a long standing and very dedicated member of the American Legion Post 313 in Larkspur where he held the position of Finance Officer and was also a member of the Legion's Honor Guard.

Dave McIntosh did not join the military or the Corte Madera Police Dept. to become a hero, but he served the call bravely and with courage. He asked for very little but gave a great deal. He was truly a part of this country's "greatest generation" and will be missed by all those who were part of his life.
