Stanley now knows "It's OK to be stressed out. It's OK to have PTSD. There are people at WWP who can help."

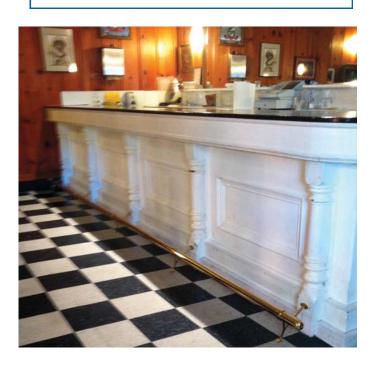
